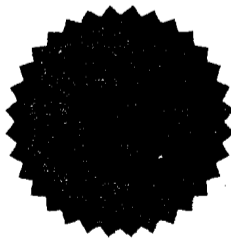

## **ARTICLE II. APPROVAL AND ADOPTION OF AMENDMENTS**

The amendments to the Corporation's Certificate of Incorporation set forth in the preceding Article were approved by all the members of the Corporation's Board of Directors and duly adopted in accordance with the provisions of section 242 of the General Corporation Law of the State of Delaware.
